

BY-LAW NO. Z.2.1

A BY-LAW TO AMEND BY-LAW NO. Z.2, BEING THE RURAL PLAN FOR THE VILLAGE OF BLACKS HARBOUR

BE IT ENACTED by the Council of the Village of Blacks Harbour as follows:

1. By-law No. Z.2, the Rural Plan for the Village of Blacks Harbour, is amended by changing the zone as shown on the Zoning Map attached to the said By-law as Schedule "A" thereof for the lands shown on Schedule "1" attached hereto and forming part hereof from COMMERCIAL ZONE (C) to HIGH DENSITY MULTI-FAMILY ZONE (R-3).

Read the second time this 18th day of May, 2022

Read the third time this 1st day of June, 2022



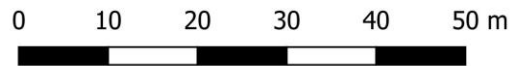
