- As a point of information, I would like to clarify that Council has received several onboarding training and that part of Council's onboarding a meeting was completed with the municipal solicitor on various legal matters including conflict of interest; this information session was completed as a benefit to all Member of Council, with all Members in attendance.
- Project Finalizing Project pricing for Water Break full repair on Riverview Avenue (modify from older project application from 2020).
- Personnel hiring of Amy Carter as Administrative Assistant/Receptionist.
- Personnel job posting was placed for the position of Fire Chief for Eastern Charlotte Fire Rescue (the combined fire services within Eastern Charlotte).
- Compiling costing for Riverview Ave. Water Line, Riverview Curb Repair and Exit 52 Culvert Extension. Also costing on generator installations for the Municipal Office and Magaguadavic Place.
- Staff has been busy with the Seasonal Start-ups of Recreational Areas such as Community Gardens, Canal Beach and baseball fields.
- Renovations (Phase 1) are now complete on the municipal office at School Street in St. George. Some updating and renovations will be completed on rural fire halls over the coming months.
- There are 2 ongoing Dangerous & Unsightly Premise files (1 Blacks Harbour, 1 St. George).
- Civic Numbering staff has been busy with civic number responsibility for the rural areas (former LSDs) as well as repairing/installing signage for Private lanes/roads.
- PCRC Upgrade ongoing received quotes for camera system, BH Public works staff has been busy with painting, repairing walkways and working with contractors on upgrades/repairs to the ice plant.
- Parks/Rec Baseball Fields upgrades to the fence crowns in both BH and SG as well as infield work at SG was completed. Also leveling of parking area in BH.
- Parks/Rec boat docks repairs and installation was completed on the dock at Canal Beach; work ongoing at Day Adventure Center.
- Parks/Rec First of June opening for Canal Beach and Splash Pad.
- Parks/Rec finish work inside of Canal Beach building; advised project engineer with concerns around retaining wall & foreign aggregate on beach.
- Housing Development working with three potential residential developers in St. George (Brunswick Street & Hillside) as well as two developments in Blacks Harbour.
- Continue to work on two possible land acquisition files; any acquisitions would require Council approval.



All regular daily checks for our Water and Waste Water Treatment system along with the lift stations and our flow meters and filter buildings. We continue to monitor and all the documents are recorded on a Daily, Weekly and Monthly. The Arena maintenance is still on going with CIMCO overhaul 1 Vilter compressor regasket 1 plate chiller & painting interior bleachers and change rooms and the up stairs YMCA has been primmed painted , replacement of wood on the walk way on curling ice surface, new doors installed Water Treatment for condenser tower is still in the install process the application have been filed with the province .Inventory for 2022 has been completed. General Maintenance Street Sweeping & side walks sweeping with the backhoe and trackless. Applied cold mix asphalt to the pot holes on the streets is on going. Repairs to lawns and damage from the snow plowing on several streets Clean up and prep the ground that settled out from previous digs last fall where new manholes have been installed. Ball field prep for 2023 season Fundy Fencing to install a few new post in the out field Refasting of the fence wire and Replace top caps and connectors as they are needed. Prep Community Garden water has been turned back on. The garden shed has been repaired from the Winter high wind damages and re-installed with trim boards for more support. Park benches Picnic Tables and Garbage boxes have been put back in designated areas. MUNICIPALITY OF EASTERN CHARLOTTE Logo's has been applied to all the fleet vehicles. Van 4 New Tires installed & new wind shield replaced waiting on Quote for body repair and paint. Trackless new hydraulic hoses and brushes for the sweeper attachment. Garbage Truck replaced the windshield had exhaust work done oil change & service remove winter tires and installed summer tires. Backhoe had new brake lines installed.

Public Works Report

Report Period: April, 2023

TRANSPORTATION

The winter snow removal equipment was all stored away for the season, with a few minor repairs done prior to. The salt/sand spreading equipment was washed down and undercoating applied to help slow down any corrosion. With winter season wrapped up we had some broken street sign posts that needed to be replaced around Town as well as some new posts and signs installed in the Back Bay area.

Sweeping has begun with our Trackless in preparation for the vacuum sweeper to come in and remove all the buildup along the main streets from the winter. Side streets are done as they fall into the schedule. There was not much sand used this past winter so the buildup should was not as excessive as past years.

A couple sets of gates were made to block off unwanted traffic at one of our lift stations and at one entrance to the north side of the river walking trail. We have the lift station gates installed and are waiting for better weather to get the other set done.

With the spring weather now here the garbage receptacles were set back out on Main St, the Day Adventure buildings were prepped for seasonal use and the cemetery road was opened up for the season.

One of the beds at the community garden needed repair this spring. A couple of the boards had rotted out and were replaced.

We assisted J Smiths crew in the demolition of a house on Brunswick St by providing flaggers for traffic.

The crew has begun the process of repairing places that plows had damaged over the winter by adding gravel or top soil as needed.

A vagrant camp site was cleaned up out behind well 4 off Meadow rd.

New lumber was bought from a local saw mill to replace the damaged pieces on the floating boat docks for Canal. The existing pieces will be replaced with wider sections to help keep boats from any damage.

WATER

We had 2 complaints regarding cloudy water from opposite ends of Town and are likely not related. Upon inspection it was advised for the resident to run their water until it cleared up and that we would be doing our annual spring hydrant flushing soon and should clear up any further issues.

We are moving forward on having the area on Riverview Ave repaired with a more permanent solution by replacing a section of old deteriorated water main. Quotes are being sourced for a contractor and the materials.

Ron and Rick went to the Saint John lab for a training session on the use of a turbidity metre. This will be another test to be incorporated into the existing chlorine residual one and sampling to help keep better control of water condition issues.

SEWER

The final two SLS pumps arrived for install at #8 on Campbell Hill and #11 on Fundy Bay Dr.

There has been an ongoing issue with foam and excess water boiling up from a manhole at the end of Salar Ct in the Industrial Park. A solution is still being sought for this.

Lab sampling done on discharged water from the True North wastewater treatment plant has been showing higher than normal counts in their BOD (Biochemical Oxygen Demand also sometimes called the Biological Oxygen Demand). This is a standard test used to measure the levels of organic water pollution by checking the number of pollutants the water contains. The higher the BOD count is the greater the amount of pollutants in the water sample, which reduces the amount of oxygen needed to allow micro organisms to break down the solids. Recent phone conversations with the maintenance supervisor assures us the problem will be corrected soon as they have direction from their chemical supplier to bring the wastewater discharge back into parameters.

We are currently waiting on True North maintenance and their chemical supplier to find a solution to this problem. So far our lagoon testing has not shown any drastic changes in our results, but we are closely monitoring things to keep ahead of any adverse affects.
