BE IT FURTHER RESOLVED that the above-noted appointment shall continue as long as the person is employed/retained by the local government, or limited/servicing body, or rescinded by Council.

The men from Lake Utopia Paper who helped with the scoreclock were: Dale Chafey, Mill Manger; Craig Dewar, maintenance planner; Dawson Borthwick and Councillor Hatt, electricians; and, Tyson Dewar and Devon Shannon, mechanical. The estimated cost of the work was \$11,000.
