



- Finance – The Finance team is busy with finalizing the draft of the 2024 budget. The financial statements are available on the website and originals have been set to the Province.
- Working on drainage issue between Magaguadavic Place & Granite Town Hotel.
- Weekly work continues on the water (and wastewater) projects for St. George and Blacks Harbour water networks. In St. George, test wells are scheduled to start this month and preliminary reporting/applications for lagoon work is underway. In Blacks Harbour, we have secured temporary land agreements with property owners on test wells in the Jackson/Woodland Road aquifer. On the subject of Blacks Harbour water, staff conducts both daily and weekly water testing for biological, chlorination levels and turbidity levels. Like the St. George water network, all water testing is set by the Province’s Department of Health and reporting is audited. To date, all testing has been within permitted levels, however, there have been causes, particularly on the weekends/holidays, where we suspect levels will bounce up. In early 2024 we will be installing a 24/7 turbidity meter on the system.
- Staff is working on a Use of Municipal Building & Spaces policy which will be coming to Council over the next month. In addition, several by-laws are in the works such as an Animal Protection bylaw which is moving through draft.
- The tender auctions for the former Day Adventure Center buildings are now open. Once the buildings are removed, we will look at possible projects on the future use of the park area. An open house is scheduled for Monday, November 20, for interested parties to look through the buildings. The tender closes on Friday, December 8, at 1:00 pm.
- Properties – Meeting weekly with By-Law Enforcement on 15+ Dangerous & Unsightly properties files. Three files progressed to Council for Enforcement of Orders.
- Arena – Work continues on upgrades to the arena. Awaiting on lighting and electrical upgrades.
- Completed a RDC funding restoration project for the municipal-owned/maintained Blacks Harbour Community Cemetery. The project was the first of a three-year restoration project (much like what was completed with the St. Mark’s Cemetery in St. George). Over the winter months, a number of additions will be made at the museum & archives.
- Finalizing an overview, scope and cost of a preliminary study of water/wastewater services at Exit 56 in Upper L’Etang.
- Several Public Works & Administration staff, along with some members of the Fire Department, completed a Narcan administering course. Narcan kits are in place at the municipal office, Magaguadavic Place, and arena.

## *Planning update*

- PRAC update:
  - No Eastern Charlotte files handled on September 21<sup>st</sup> regular meeting;
  - One (1) private access subdivision approved (The Bluff Subdivision, Route 785, Utopia) approved on October 19<sup>th</sup> regular meeting;
  - Hosted training session for the PRAC on the Statements of Public Interest Regulation on October 31<sup>st</sup>; and,
  - Next regular meeting of PRAC to be held on November 16<sup>th</sup>
- Rezoning by-law under the Village of Blacks Harbour Rural Plan By-law and separate planning report attached;
- Recommending that Council adopt a uniform planning fees by-law (see attached) which would harmonize the fees the RSC collects on-behalf of Eastern Charlotte across the municipal territory for the miscellaneous planning services (eg. zoning confirmation letters) other than rezoning/permitting/subdivision – **Recommended action:** *that Council request the written views of PRAC on the proposed by-law in accordance with section 110 of the Community Planning Act and give readings to the by-law;* and,
- SNBSC Planning Division hired a Planning & GIS Technician to assist with mapping.

## *Development update*

- Eighty-six (86) building/demolition or development permits issued to date in 2023 – construction value: \$9,136,930.00
- Twenty-seven (27) zoning confirmation letters issued to date – four (4) new;
- Ten (10) variances or terms/conditions approvals issued to date – no change;
- Twenty-three (23) subdivision approvals granted – two (2) new, totaling:
  - twenty-five lots (25) and seven (7) parcels of land.

## *Enforcement update*

- Fifty-four (54) enforcement files have been opened in Eastern Charlotte for Community Planning Act, Building Code Administration Act, or Dangerous or Unightly Premises Act violations – to date seventeen (17) of those files have been closed for achieving compliance.

Public Works will continue to do regular checks on our Water and Waste Water treatment system. This is done on a daily, weekly and monthly schedule. All documents are recorded and filed. These documents are later used for reports submitted to the Dept of Environment and Dept of Health. Turbidity checks and Chlorine residual are kept in accordance with the approval to operate on a daily schedule. General Maintenance and checks to all Equipment is ongoing. We have had a few complaints regarding turbidity we will continue to monitor and do checks on a daily schedule all results are recorded and The Municipality of Eastern Charlotte will continue to monitor the water quality and we will go above and beyond our normal test sites if required.

Remembrance Day Banners have been put up Lest We Forget Remembering with Respect and Honour.

The Water has been shut off at community garden for the season.

A New 3/4 inch Cooper line @ 763 & 765 Main St has been installed, and we will continue to replace new curb boxes with new rods and pins as needed. Please do not damage our shut off valves. Repairs to the privacy fence behind Public Works building has been completed. Trackless & Trailer Prepared for the Winter and the Snow Blower and Snow plow Prepared for the winter season. The 3-TON Plow is ready for the winter. Backhoe plow blades are ready Prep for winter. The

Garbage Truck has had the winter tires installed a new air supply tank replaced and the oil and filter we had to do repairs to the tipper for garbage bins .

The Backhoe has had new battery connectors replaced. We started doing asphalt 115 tons applied so far , We have started to pump out the fire hydrants barrels so they don't freeze and installed markers on hydrants .

## TRANSPORTATION

The Veteran banners were installed for the season of Remembrance.

Vehicle maintenance and repairs have taken up more time this fall due the aging of the fleet. The hydraulic pump on the Trackless was sent out to have new parts and seals installed as this was proven to be cheaper than replacing it with a new pump.

With fall in full swing and the leaves falling off trees we are having to keep the catch basins cleaned out on a regular basis to make sure they are not plugged up in the event of a rain storm.

The guard railing on Clinch Street was re installed after the bank was rebuilt facing the salt water basin. The bank gave away after a storm and washed a large portion away.

We had to contend with a beaver issue on Brunswick Street, where dam construction caused water to back up into a residence's back yard.

The new boundary signs have been going up to signify when you are entering a local community. Some are waiting for the proper location before being installed.

The water break area in front of the Elementary School was patched with asphalt. The entire job has yet to be completed as a contractor cannot be secured to do the concrete work yet. We also added an extra 2 inches of asphalt to the Riverview Ave water break area in hopes the DTI trucks will not tear the area up with the winter plowing. The infrastructure is due to have some upgrades done in the spring and the whole area will be restored then.

We assisted the Blacks Harbour crew in getting some asphalt work done to finish their season. Codey went down with our roller and other tools to help for two days and get some areas finished up for the season.

Winter preparations to the equipment plows has been ramped up to make sure everything is in good working order to start the season.

The ditches along Mount Pleasant and Manor Road were cleared of overgrown bushes to help with sightlines of traffic at intersections, and to make it more aesthetically pleasing.

## WATER

Water usage for September was approximately 8,552,800 million gallons, for an average of 285,093/day. This is a calculated total and not completely measured as the electronic interface for well 2 was damaged in a lightning storm and the new replacement has not come yet.

Well 6 chlorine injection system is still having some sporadic problems, mainly in keeping a consistent chlorine residual due to not enough being injected into the water system. A repair was done and the pump is now working as it should.

We had CBCL down to plot more service shutoffs on Main Street East in preparation of having them added to the mapping application. Services along Riverview Avenue were also added, up as far as Hillcrest Drive.

The fall hydrant flushing was done this past month during which we found two hydrants that needed to be repaired, either due to leaks or broken internal parts. All parts were in stock and the repairs were carried out the same day so we did not have any hydrants out of service for more than a few hours.

Our drinking water zones sampling map had to be updated to show the current and new infrastructure. The additions included well 6 and the renovated well 2B. These changes were made at the request of the DELG representative Joyce Wang who oversees our water and wastewater operations.

## SEWER

The new pump for SLS #4 come and was installed, getting that station back to full capacity.

## RECREATION

The floating docks at Canal and the Day Adventure Centre were taken out of the water for the season. The new canteen building at Canal Beach was winterized at the same time.
